- 4. In the Item 2, legal approvals are suitable for law and administration which are signed by authority.
- 5. In the Item 5, if the investor owns the site, the property ownership certificate and its copy must be submitted for assessment; if the site is rented, the investor must sign a rent contract with the valid period for one year or above, and submit the contract and the copy of the landlord's property ownership certificate; if the copy of the landlord's property ownership certificate cannot be submitted immediately, other relevant certificates with the effect of ownership identification must be submitted. If the renter engaged in hotel and restaurant, shall submit the copy of business license.
- 6. The Item 6, the copy of duplicate of business license must be made by chop.
- 7. The Item 7, earlier setup examination & approval documents or certificates are applicable to branch of foreign invest company, which should be approved within the regular date.
